Transeo Deal Club



- 1st meeting in November 2019 in Bucharest with 20 opportunities ...
- Now 19 meetings, with 243 active opportunities
 - 184 sell-side
 - 59 buy-side
- The evolution in figures:
 - **370** total opportunities exchanged on the period 2019-2022
 - Total sell-side (evolution new profiles) : 2019 = 19 (19) ; 2020 = 97 (78) ; 2021 = 165 (68) ; 2022 = 260 (95)
 - Total buy-side (evolution new profiles): 2019 = 3 (3); 2020 = 16 (13); 2021 = 51 (35);
 2022 = 80 (29)
- Model of monthly meetings adopted in 2022
- Launch of the new digital platform on 29 September in Munich
- In 2022, we had 8 meetings
- ... In 2023 we will have 8 meetings, among them 2 in-person meetings (Charleroi & Malta)
